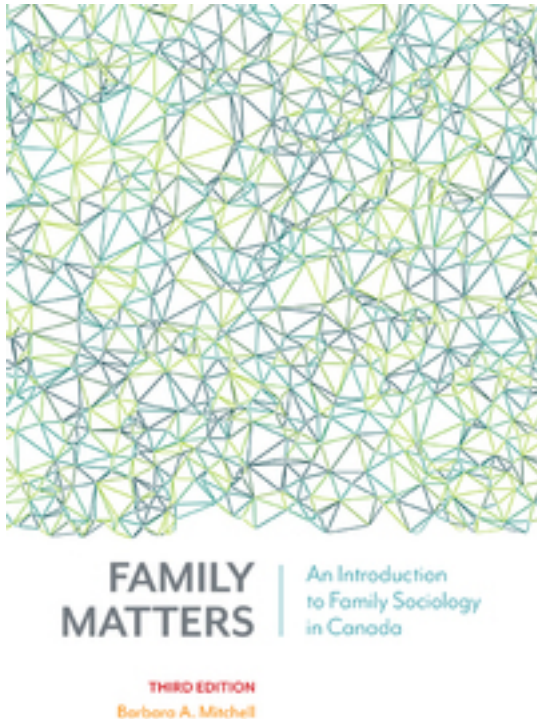


Family Matters, Third Edition
